We all know that Smart phones, tablets, laptop computers, thumb drives are convenient and easy to use. They also introduce risk to personal privacy and enterprise data, are highly portable and are frequently unprotected. They are easy to steal or lose, and unless precautions are taken, an unauthorized person can gain access to that information. The results can include crippled devices, personal data loss, disclosure of non-public enterprise data, and potential disciplinary actions for the device owner. This presentation provides the Top 10 recommendations for securing mobile devices to protect against common threats.



Our speaker will be Bill Lisse, CISSP, CISA, CIPP, CGEIT, PMP from OCLC. Bill is the Information Security Officer for OCLC Online Computer Library Center Inc. OCLC is the world's largest consortia of libraries which interconnects 72,000 libraries in over 170 countries. He is responsible for managing OCLC's Global Information Security Management System and has more than 25 years of experience in information security, IT audit, and investigations supporting information assurance in both commercial and governmental enterprises.

Juniper Networks will also make a presentation on the JUNOS Pulse mobile security suite developed in Columbus as SMobile Systems. This system provides handsets with AV, anti-theft lock/wipe/locate, backup/restore, and "parental controls" in partnership with mobile operators worldwide.
